-The pupil is isolated and their parents/carers contacted and the pupil isolates for 10 days.

-Parent/Carers to be made aware, where need identified: They could be fined if you do not self-isolate following a notification by NHS Test and Trace.

-Advise Parents/Carers and Staff they may be entitled to a one-off payment of £500 through the NHS Test and Trace Support Payment
